

Courses with Exemptions to UEL Academic Regulations

All exemptions are Approved by the University Academic Board

Academic Regulations govern the academic activity in the delivery of courses and apply to both staff and students.

On occasion, there may be a reason to exempt a course from the Regulations, where this is a case, a rationale is submitted to the Education & Experience Committee, with final Approval by the University's Academic Board.
